## Tarapur Branch Closure Notice

As part of our ongoing commitment to providing the right level of service to our customers, we continually review our branch network presence in Nadia district to ensure we are in the right locations which reflects how our customers choose to do business with us. After careful evaluation, we have taken the difficult decision to close Tarapur branch of Nadia District Central Cooperative Bank Ltd on **25<sup>th</sup> August, 2025** after obtaining necessary permission from higher authorities as per branch closure procedure.

### How we came to our closure decision

It has been observed with great concern that Tarapur Branch under Nadia District Central Cooperative Bank Ltd had been incurring loss for the consecutive six financial years since inception, amounting to around Rs 2.00 Crore cumulatively. Matter of improvement of financial condition of the branch seems to be very much impossible in future. There have been very few footfalls at the said branch since inception, which has become a major area of concern for business continuity at Tarapur branch.





Dear Sir,

In reference to your letter and upon verification of the documents submitted to this end, I am directed to accord approval for closure of Tarapur Branch of Nadia DCCB Ltd. You are directed to take the following actions in terms of RBI Circular no. DoR.REG/LIC.No.54/19.51.052/2023-24 dated 30/10/2023:

1. The bank should give two months' notice in advance to all existing depositors/ clients of the branch through press release in local leading newspapers as well as communicate to each constituent of the branch, well in advance of closure of the branch.
2. The bank should return the original licence/s issued for the closed branch to the Regional Office concerned of Reserve Bank.
3. The disposal of the premises occupied by the erstwhile branch should be reported to the Regional Office concerned, NABARD and the RCS office.
4. The bank should report to the Regional Office concerned of Reserve Bank and NABARD, in Form VI prescribed under Rule 8 of Banking Regulations (Co-operative Societies) Rules, 1966 after closing the branches, within one month from the date of closure, along with copies of the relative Board resolution and RCS approval.
5. The bank should preserve all the relevant records and make them available to NABARD inspection team for scrutiny during the course of inspection.
